General Fund. The Public Liability Insurance renewal premium of £227.86 was paid. The United Service offering on 19th October totalled £252.88 has been passed on to Eden's Project for which they have thanked us. £16 paid for the St Peters Christmas Tree Festival & £75 to Rev Colin Chapman for his attendance at the Christian/Muslim dialogue.

Kettle & Fish. The net refreshment sales bankings, Sept to Dec, totalled £1962.98 (8 openings) – of this £196.30 was transferred to the Dorcas Fund. £479.06 was paid for catering goods, £100.83 to Primo Coffee, £35.55 to St Johns Traidcraft, £62.84 for printer cartridges etc & £350 rent to Friends of St Peters.

Dorcas Fund. £210.00 was given for a counselling course at St Andrews & £100.00 contributed towards a sensory garden for a young severely disabled child.
